On-Going

A new routine and workflow with at-home work due to COVID-19 has slowed productivity. However, as time moves forward and the routine becomes more engrained, productivity improves. Challenges still exist around connecting with staff and partners through electronic means, where physical interaction would be more efficient. I believe I'm committing 8-hours of work each day, though dispersed beyond a standard 8am to 5pm window.

As the Public Relations Manager, my own familiarity with all LRAPA's projects and partnerships is growing and I become more confident in which tasks require immediate attention, and which can be attended to later.

Big projects for the month of May include working with the UO on a community meeting – likely electronic – discussing Purple Air Sensors and the community's immediate involvement. The Oakridge Air (Tag) website will launch in the month of May. Significant progress is expected to be made on LRAPA's annual report, as well as beginning a report to the EPA of the LRAPA Woodsmoke Reduction project agreement due in June.

I am also on an email thread with NACAA Public Outreach to compile online materials suitable for public education of air topic during the closure of physical schools. The goal is to compile a list of resources on our website to point parents to for homeschooling assignments and opportunities.

<u>Asbestos</u>

Mail outs of asbestos informational packages to Lane County residents who received building permits for remodeling projects and new homeowners. Residents are directed to contact LRAPA with any questions. Residents of the cities of Eugene, Springfield and Coburg now receive information with their permits. LRAPA will keep the local planning departments and contractors, upon request, stocked with the fliers so that they can help get the word out to residents who might encounter asbestos-containing materials while remodeling their homes.






