- 2. Industry – 74 total complaints: 63 for International Paper; 4 for JH Baxter; 2 for Emerald Forest Products; 2 for Delta Sand & Gravel; 1 for Aurora Innovations and 1 for Mohawk Meat.
- 3. Wildfire Efforts

July and August kept LRAPA's public affairs department busy with wildfire and smoke duties in addition to standard public affairs duties and responsibilities.

Throughout July and August, LRAPA public affairs staff participated on frequent smoke meetings with the Oregon Department of Environmental Quality (DEQ), Oregon Health Authority (OHA), fire resource advisories, as well as other local and tribal partners to coordinate smoke messaging and outreach. These meetings help LRAPA collaborate on areas of smoke concerns and provide recommended actions for people to protect their health.

LRAPA public affairs staff continue to participate on a daily (including weekend and holiday) cooperator/stakeholder meeting on the Middle Fork Complex fires. These daily meetings allow LRAPA to remain informed on firefighting approaches and resources. They also provide opportunity for LRAPA to share an air quality forecast for areas impacted by smoke with regional stakeholders in the area.

Wildfire duties and responsibilities absorb a substantial portion of staff time and will likely continue through September and early October, depending on the conclusion of the wildfire season in the Western North America.

Public Outreach Efforts

In addition to wildfires occupying much of LRAPA's public affairs time, progress continues to be made on outreach and public engagement.

LRAPA's online community survey remains open. In July, LRAPA mailed 24,926 postcards to residential addresses within 1 mile of facilities in – or soon to be in – Cleaner Air Oregon, as well as around Prairie Mountain School, in the Bethel neighborhood of Eugene. This mailing increased the number of responses to our survey and currently has 259 responses.

LRAPA will host its first facility specific community meeting on Seneca Sustainable Energy, LLC in early September. This meeting was originally scheduled to be a hybrid meeting with in-person participation possible at the Eugene Library, as well as online participation via Zoom webinar. However, after consulting with Lane County Public Health, LRAPA has moved this meeting to online-only to guard against increasing COVID-19 cases and subsequent hospitalization. Considerable public affairs staff time was committed to this meeting over the month August. LRAPA mail postcards on September 1 to any who live within a mile of Seneca Sustainable Energy, informing them of the opportunity to join the meeting and engage with LRAPA.

 - Heard more of community's concern on JHB & request community interest in an Oregon State Cancer Registry (OSCaR) study.
