Dear Chairman Pishioneri and Director Dietrich:

Thank you for bringing your concerns about the smoke situation which occurred in Oakridge and Westfir during this past wildfire season to our attention. The data you shared helps us understand the magnitude of the issue and one in which we share your concerns. While smoke is an unavoidable aspect of wildfires, we do recognize the potential public health hazard it represents.

It might be helpful for you to know that from the start this fire was managed for full suppression, i.e., all the work was conducted to extinguish or limit wildfire spread. Unfortunately, given the weather, the terrain, and the fuels we were working with, we were not able to contain the fire until after the arrival of significant precipitation in late October. From the first day of detection, high values at risk from this fire were the communities of Oakridge and Westfir, highway 58 corridor and Waldo Lake water quality.

However, there were several actions which were undertaken to help mitigate the impacts of smoke on affected communities during this incident. We deployed Air Resources Advisors (ARAs) continuously from August 18<sup>th</sup> through October 28<sup>th</sup>. The ARAs provide smoke forecasts, deployed and maintained temporary smoke monitors, attended public meetings, and further assisted with public messaging. Along with our regional air quality specialists, ARAs participated in the State Wildfire Smoke Coordination calls. During those calls, we provide additional information about the fire, as well as share information about the local smoke situation with all call participants (primarily air quality agency personnel and public health officials). These efforts help mitigate smoke impacts by providing information to the public to make informed choices on how to reduce their exposure. Additionally, our regional air quality specialist participated in daily Fire and Aviation Management calls which help us with situational awareness regarding wildfire smoke.

In addition to the incident-specific response, we also have long-term plans to reduce the threat of wildfire to potentially affected communities. Our forest fuels management plan identifies areas of high probability of receiving fire, highly valued resources and assets which can be negatively or positively affected by fire, and locations where fuel treatments are needed to reduce the negative consequences of fire. We would be glad to share maps of where these areas are located and our plans for treating these areas.

We are also developing new methods to identify early in a wildfire incident whether it will likely cause long-term smoke impacts in specific communities. Such information is then considered in our management actions and public information sharing. These techniques were piloted this year and we will continue to develop and refine them into the future.

We welcome the opportunity to meet with you to discuss the Cedar Creek Fire, how it was managed, how the community of Oakridge was affected, what we could do better, as well as our long-term plans for reducing wildfire risk. 
The Lane Regional Air Protection Agency (LRAPA) Board of Directors (LRAPA Board) and Executive Director are writing to you, as part of the Agency's mission to protect public health. As you may know, LRAPA is the local air authority in Lane County, Oregon which includes the Oakridge-Westfir area. We know wildfires are larger, occur more frequently, and are more difficult to control or even extinguish with limited resources, difficult terrain, and challenging weather conditions. We appreciate the fire response has been large and tireless to date and need these efforts to continue.

For your information, LRAPA's ambient air monitoring network includes particulate PM<sub>2.5</sub> and air toxics sampling in the City of Oakridge. The following tables outline the severity of the smoke impacts LRAPA's monitors have recorded, since the Cedar Creek fire started having major smoke impacts on the people of Oakridge-Westfir area on September 1, 2022. These monitored levels have, at times, represented some of the worst air quality on the planet.

The LRAPA Board of Directors want to make sure you are aware of the severity of the measured particulate levels that are continuing to create unhealthy to hazardous health conditions for those living in the Oakridge area. The Oakridge-Westfir community is above the 80<sup>th</sup> percentile for low income, unemployment, those without a high school education, and population over the age of 64. Oakridge-Westfir residents continue to report significant acute health effects caused by the hazardous air quality and worry about chronic health effects they may experience from this continued exposure. The typical fall precipitation has yet to arrive in Oregon, although there is hope for a weather change later this week to bring rain and begin to counteract the unseasonably dry and warm conditions.

In the meantime, Lane County Public Health, the Oregon Health Authority, and Oregon Department of Human Services has partnered with Oregon Air to provide and distribute over 1,000 free individual air purifiers to people living in the Oakridge-Westfir area. As mentioned before, many of these people are low income and elderly, making relocation for an extended time difficult without some level of support. There is still an unmet need for 500 more units.

We look forward to your continued efforts and welcome any opportunity to meet with you and other federal, state, and local agencies (copied below) to discuss the progress being made and lessons learned. During this fire event, a parallel crisis to saving homes has emerged. It's the prolonged hazardous ambient air event that requires relocation or an adequate shelter-in-place program ready to go when needed. Perhaps it is time for a two-pronged response plan that makes air quality a more active part of incident command. It remains to be seen how this approach will be resourced. Thank you for your service to the public and prompt attention to these important issues. LRAPA can be reached at (541) 736-1056.

January 2023 Public Affairs Monthly Summary

#### Smoke management from wood stoves, outdoor burning, and Wildfires

Smoke management efforts through January focused on home wood heating curtailment during periods of prolonged air stagnation. Two home wood heating days were called in January in Eugene, Springfield, and Oakridge. Air quality in these areas avoided reaching poor levels that would have required red home wood heating days.

Long range weather outlooks suggest more air stagnation periods are possible through February and early March. Additional yellow or red days may be called if warranted by weather conditions.

Home wood heating season runs through May 31. LRAPA continues to publish daily Home Wood Heating advisories for Eugene/Springfield and Oakridge. During the season LRAPA prioritizes staff time to assess potential air stagnation episodes and the need for Yellow/Red advisory days during those episodes.

#### **Public outreach efforts**

LRAPA's executive director attended a City of Springfield city council work session in early January. This presentation provided an overview of LRAPA's role implementing the federal and state air regulations in Lane County and highlighted the service and work the Agency accomplished through the county.

LRAPA's 2022 annual report was published on January 30, 2023. This publication highlights work, and accomplishments achieve throughout the year. New with the 2022 year, an online version of the report presented in an <a href="mailto:ArcGis StoryMap">ArcGis StoryMap</a>. The intent of producing this online version of the report is to encourage more Lane County residents to see, interact with, and read the report. This report can be easily found and accessed from LRAPA's Community Center webpage.
