**LEGAL NOTICE OF INTENT TO ISSUE SIMPLE AIR
CONTAMINANT DISCHARGED PERMIT NO. 203155 (ACDP 203155)**

In accordance with title 37 of Lane Regional Air Protection Agency's Rules and Regulations, Grain Millers, Inc. applied for the renewal of a Simple Air Contaminant Discharge Permit (Simple ACDP). As a Simple ACDP source, the permit will contain Plant Site Emission Limits (PSELs) for PM, PM₁₀, PM_{2.5}, CO, NO_x, SO₂, VOC and GHG emitted at more than the de minimis level in accordance with LRAPA title 42 and Oregon Administrative Rules chapter 340, division 222.

Emissions will be limited by the permit to the PSEL level for the stated pollutants. None of these emission limits exceed the Significant Emission Rate (SER) established by Lane Regional Air Protection Agency (LRAPA).

The following table presents maximum allowable emissions of criteria pollutants for the facility. The proposed emission limit reflects maximum emissions the facility will be able to emit under the proposed permit.
